	E-Planning. Having attended meetings on this subject the Chairman wished to	
	recommend the proposed electronic means of communicating Planning	
	Applications despite the 'teething' problems currently being experienced with	
	the on-line system, as he felt these would be 'ironed' out in due course.	
2010-11-02	PCSO Report: PCSO Groves was pleased to report very little anti social	
	behaviour in Delabole and St Teath. He was, however, eager to pass on a warning	
	that slate garden furniture and fittings was being reported stolen in the local	
	area. Also he was aware of several cases of Catalytic Converters being removed	
	from cars, especially 4x4s, whilst parked overnight. These he felt were being	
	taken because of the platinum content for which a high price could be expected.	
	Cllr Aston again raised concerns about the youths congregating at night in	
	Pengelly. PCSO Groves would make sure patrols knew of the problem. The poor	
	state of traffic management at the junction of High Street and Pengelly was	
	again highlighted. PCSO Groves would bring this to the attention of parking	
	enforcement officers.

It was decided a quote should be sought from Western Power for the installation of a meter to accurately record the amount of electricity consumed in the running of Delabole Millenium Clock.	Clerk.
